PLANETEL AND EVISO SIGN POWER SUPPLY AGREEMENT

Treviolo (Bergamo), 26 April 2021 – Planetel S.p.A., (“**the Company**” or “**Planetel**”), the parent company of the group that bears its name, operating nationwide in the telecommunications sector, listed on the AIM Italia multilateral trading system organised and run by Borsa Italiana S.p.A., announces that it has signed power-supply agreement with eVISO S.p.A., a company that has developed an artificial intelligence platform that creates value in the physical commodities market. The agreement concerns power supplies and developing and enhancing Planetel’s PODs. It comes into effect on 1 June 2021.

Under the agreement, eVISO will supply power to about a thousand of Planetel’s points of delivery (PODs), and thus guarantee a boost to the efficiency of every single Planetel cabinet, also thanks to an advanced technological monitoring service that is enhanced by the artificial intelligence of the eVISO platform. This service provides technical analysis and control of the continuity of the power supply to the single POD that will enable any irregularities in the supply to the consumer units to be forestalled and the running of the high number of Planetel PODs to be streamlined. The value of the agreement remains confidential.

Mirko Mare, Planetel’s Managing Director, declares: *“We are delighted about this new partnership with eVISO, our new partner for power. The eVISO platform’s monitoring and analysis of the power part of our systems will bring great benefits, and optimize still further the operational continuity of our optic fibre network. Owing to the monitoring technology and the consumption analytical capacity that have been enhanced by the artificial intelligence of the eVISO platform, we will be able to anticipate any operating irregularities or interruptions in our cabinets, intervening promptly to obtain maximum efficiency from our network”*.

Gianfranco Sorasio, the CEO of eVISO comments: *“We are delighted with the agreement signed with Planetel and being able to provide them with our services to achieve greater efficiency, analysis and control of their PODs. This synergy has come about from a shared vision of the technological efficiency of both businesses, which are both dedicated to innovation and improving processes, products and technological services”*.
